CONTEST RULES & REGULATIONS (“Official Rules and Regulations”)

1. NO PURCHASE NECESSARY

2. ELIGIBILITY

This Contest (“Contest”) starts on April 17, 2023 (“Contest Start Date”) and ends on May 26, 2023 (“Contest End Date”). To be eligible for this Contest, on-line entries must be received on or before, 11:59 p.m. (EST) Eastern Standard Time on the Contest End Date. Late entries will not be accepted.

This Contest is only open to:

- a) residents of Ontario, Canada who reside in the Great Lakes Lawn Care Inc. (“Great Lakes”) service area who have reached the age of majority and are a legal homeowner within Great Lakes service area; and
- b) All entrants (“Entrants”) must own and currently reside at the property address described on the entry. The property cannot be a condominium unit where the landscaping and lawn maintenance is arranged by the Condominium Corporation or its manager.

Individuals who reside outside of the Great Lakes service area are not eligible to enter this Contest.

Employees of Great Lakes and their representatives, agents, advertising and promotional agencies, affiliated and related companies, and members of the immediate family (parents, children, siblings and spouse, regardless of where they live) and household of such employees; and its owners, affiliates, and members of their immediate families, are not eligible.

3. HOW TO ENTER

Only one on-line entry is permitted per qualifying residence. All multiple entries or mass entries submitted are automatically disqualified. You may only enter by:

On-line Entry:

Logging onto www.greatlakealawn.ca and complete an on-line entry form in full and click “Enter Now” to submit your entry for receipt by Contest End Date of 11:59 pm. (EST), May 26, 2023. For purposes of these Official Rules and Regulations, “receipt” of an on-line entry occurs when the entry email is received successfully and recorded by a Great Lakes Representative upon the entrant clicking the “Enter Now” button (“Entry Data”). Any automated computer receipt (such as one confirming delivery of email) does not constitute proof of actual receipt by a Great Lakes Representative of an entry for purposes of these Official Rules and Regulations. In your entry, you will be asked to provide your first and last name, residential address, city, phone number, email address and other information about the property. All mandatory fields must be completed. Great Lakes is not responsible for late, lost, misdirected or incomplete entries, which will be void. The use of any automated equipment to participate in this Contest is prohibited. In the event of a dispute as to who submitted an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. “Authorized account holder” is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. If a selected entrant’s entry is an Internet entry, the selected entrant may be required to provide Great Lakes with proof that the selected entrant is the authorized account holder of the e-mail address associated with the selected entry. Entrants are required to provide truthful and accurate information in all Contest entries and a Great Lakes Representative will disqualify any entry that the Great Lakes Representative determines, in its sole discretion, to be false, fraudulent, or incomplete.
